## **CRITERIA**

Applications must be submitted with the necessary documentation for candidates to qualify for the awards. Only current year recipients may receive their awards at the RE/MAX International Convention. Career Awards are not given out at the RE/MAX of Western Canada Annual Conference. Applications may be sent in at any time during the year as an associate qualifies. Once approved at RE/MAX International, associates may use the corresponding logo on business cards and print pieces.

### **Hall of Fame (first presented in 1987):**

- ✓ \$1 million in earned commissions with RE/MAX



### **Lifetime Achievement (first presented in 1992):**

- ✓ \$3 million in earned commissions with RE/MAX AND
- ✓ At least seven years of service with RE/MAX AND
- ✓ Have attained the Hall of Fame Award



### **Circle of Legends (first presented in 2002):**

- ✓ \$10 million in earned commissions with RE/MAX AND
- ✓ Completed 10 years of service with RE/MAX AND



For each of these awards, the following back-up documentation will be accepted:

- T4As OR
- Schedule "C" or Income Tax Form OR
- Trade Record Sheet OR
- Cancelled cheques (copies of both sides) OR
- Current year-to-date office reports certified by current Broker Owner
